YOUR RIGHTS AS THE INJURED PARTY IN CRIMINAL PROCEEDINGS IN BOSNIA AND HERZEGOVINA

YOUR CORE RIGHTS ARE

Right to report a crime

Right to be informed on your rights, decisions, and remedies

Right to pursue a property claim Right to take part in the trial and be heard before the court to a reasonable extent to complain against negative prosecutorial decisions and appeal against a certain aspect of the verdict



"I am the injured party. What should I do?"



REPORT the criminal offense to the police/prosecutor WITHOUT ANY DELAY.

FILE THE REPORT IN WRITING OR VERBALLY AS ACCURATELY AS POSSIBLE. IF THE REPORT IS DONE VERBALLY OR BY PHONE, MINUTES OF THE CONVERSATION WILL BE TAKEN, OR AN OFFICIAL NOTE MADE.

- Inform the police/prosecutor in detail about your injuries and any loss or damage that you have suffered because of the crime. Tell them about any loss of earnings, and all the damage, pain, and suffering that you may have experienced. They are trained professionals to whom you can trust, who will respect you, and have a full understanding of your situation. They will not shame you or discredit you in any way.
- Keep any documents and other evidence related to these matters, if available, and submit them to the prosecutor, especially to support your property claim in the criminal proceedings.
- Ask the police which prosecutor's office oversees the investigation in your case and make sure to keep yourself informed on the developments in the case.
- Seek legal aid to protect and exercise your rights. Free legal aid is provided to the citizens of BiH under certain conditions and there are various options to choose from, coming from state institutions to civil society organisations.



Right to be informed on your rights, decisions, and remedies



to be informed about the prosecutor's decision not to conduct or to cease the investigation, including the reasons why, in writing, and within three (3) days.



to complain against these decisions within eight
(8) days - the complaint can be submitted to the prosecutor of the Prosecutor's Office of BiH or the Prosecutor's Office of Brcko District of BiH, depending on who made the decision, while in the Federation of BiH and Republika Srpska the complaint can be submitted to the Chief Prosecutor of the Prosecutor's Office of the Federation of BiH and the Chief Prosecutor of the Prosecutor's Office of Republika Srpska respectively.



to be informed by the court if the prosecutor and the perpetrator conclude a plea bargain agreement which is accepted by the court



to be informed of the prosecutor's decision to withdraw the indictment and the court's decision to suspend criminal proceedings.

Right to take part in the trial and be heard before the court to a reasonable extent



to be invited to and attend the hearing of a witness or a court expert outside the courtroom as well as the reconstruction of the event.




to testify during the investigation and at the main trial based on the legal provisions on the manner of hearing of specific categories of witnesses



to attend the main trial and give a closing statement on the circumstances of the property claim



to receive a copy of the verdict



on the property claim and the costs of criminal proceedings









Right to pursue a property claim



to submit a property claim1 with the prosecutor during the investigation or with the court at the trial;



to propose the procedure of mediation regarding the property claim



to pursue the property claim through a civil action if the accused is acquitted, charges reject or trial discontinued.



The right to seek legal aid to protect and exercise your rights

Free legal aid is provided to the citizens of BiH under certain conditions and there are various options to choose from, coming from state institutions to civil society organisations.
